Purpose: Feature attraction - Local contest only

Rules:

1. For Ages (6-8) contestant must have reached her 6th birthday but not her 9th birthday by September 1, 2009.
2. For Ages (9-12) contestant must have reached her 9th birthday but not her 13th birthday by September 1, 2009.
3. No pageant wear or strapless dresses are allowed. No makeup is allowed, including body glitter. Contestants will not be allowed to wear or carry flowers.
4. Contestants will be judged on beauty, poise, personality, and rule #3.
5. The contestant must attach a copy of her birth certificate to the entry form.
6. Contestants must reside within the boundaries of Coffee County or the corporate city limits of Tullahoma for a minimum of one year prior to the contest.
7. A non-refundable fee of \$20 must accompany the entry form.
8. Each contestant will be allowed one person back stage with her. If more than one person is found backstage, the contestant will be disqualified.
9. There will be a late fee after September 1st of \$75.00. No entries will be taken after September 8th.

Note: Any contestant that does not abide by the dress code (Rule #3) will not be a contender for the top 10 winners at the judge's discretion.
