## Rules:

1. Each contestant must have reached her fourth birthday but not her sixth birthday on September 1, 2010.
2. No pageant wear, such as strapless dresses, dresses with excessive sequins or beading, or floor-length formals. Dress should be age-appropriate. No makeup is allowed, including body glitter.
3. Contestants will be judged **on beauty, poise, personality, and rule #2** at discretion of judges.
4. Each contestant must have a copy of her birth certificate attached to the entry form.
5. Each contestant must reside within the boundaries of Coffee County or the corporate city limits of Tullahoma for a minimum of one year prior to the contest.
6. A non-refundable fee of \$20 must accompany the entry form.
7. Each contestant will be allowed one person back stage with her. **If more than one person is found backstage, the contestant will be disqualified.**
8. **There will be a late fee after September 1st of \$75.00. No late entries will be taken after September 7th.**

**Note:** Contestants that do not abide by the dress code (Rule #2) will not be a contender for the top 10 winners at the judge's discretion.
